CSBOA Rules Interpreter: Steve Riker

UNIFORMS- COMPRESSION SHORTS & SLEEVES

- Except for knee braces, anything worn on the arm or leg is considered to be a sleeve and must meet the following color restrictions:
- 1) dominant color of the jersey, beige, white or black
- 2) same color compression tights, shorts or sleeves on all teammates
- 3) same color compression tights, shorts or sleeves as any wrist bands or headbands on any teammate

PENALTY:

- There is no specific penalty if a player wears apparel that does not comply with color and/or logo restrictions. The player simply may **not participate** while wearing the illegal items.

UNDERSHIRTS:

- Undershirts must be one color that is similar to the dominant color of the jersey. The team in the dark uniforms may also wear black undershirts, however all undershirts must be the same color. All edges of the undershirts must be hemmed. An individuals undershirt sleeves must be the same length.

PENALTY:

- There is no specific penalty if a player wears apparel that does not comply with a color and/or logo restrictions. The player simply may **not participate** while wearing their illegal items.

BRACES, CASTS & GUARDS

- If a brace, cast or guard is made of an inflexible and hard substance such as plaster, plastic or metal, it may not be worn on or below the elbow. Even if the brace, cast or guard is covered with soft padding, it is still illegal.
- If a brace, cast or guard made of a hard, stiff substance is worn on the upper arm or shoulder, it must be padded with a layer of at least 1/2 inch of closed cell, slow recovery foam padding.
- The referee has the authority to use their judgment and not allow a team member to participate if something creates a safety concern and is not covered directly by the rules.

INCIDENTAL CONTACT

- Incidental contact is **legal** contact. When there is contact, it does not **automatically** qualify as a foul. Contact that does not interfere with an opponents ability to make offensive or defensive maneuvers should be considered incidental.

INCIDENTAL CONTACT

- Extending arms vertically. A player does not need to lower their arms to avoid an opponent that is initiating the contact.
- Hitting an opponents hand accidentally when the hand is in contact with the ball, if the contact is incidental to the attempt to play the ball.
- Using hands or arms to protect part of the body in recoil action as opposed to pushing action
- Severe or non-severe contact by two opponents in equally favorable positions

INCIDENTAL CONTACT

- Contact after the ball has become dead, unless ruled intentional, flagrant, or committed by or on an airborne shooter

FIGHTING

- Fighting can occur while the ball is dead or alive. Fighting is always considered flagrant and includes, without being limited to, combative acts that include the following:

FIGHTING

- **Attempting** to hit, punch or kick any part of the body, **regardless** of whether contact is made
- Committing an sporting act that causes an opponent to fight
- Coaches may leave the bench area any time to attempt to prevent or **de-escalate** a fight
- Any player involved in a fight is disqualified and assessed a flagrant personal or flagrant technical foul.

FIGHTING

- Please review pages 106, 107 and 108 in the IAABO Handbook about what to do with “PLAYERS ON THE COURT” & ”BENCH PERSONNEL LEAVING THE BENCH AREA” if a fight breaks out during your contest.
